

Victoria Park: Terms and Conditions of Entry

Definitions and Interpretation

“The Venue” means the premises known as Victoria Park, at Victoria Avenue, St Sampson GY2 4BB

“Management” means the management staff of either Spirit Victoria LBG, Guernsey FC, or Guernsey FA

“Staff” means any member of staff or volunteer engaged by any of the above entities to work at the Venue, outside the Venue, or at any other Venue for any event which occurs outside the venue

1. General Admission Conditions

1.1 All spectators must purchase a valid ticket for entry to the venue. Tickets are non-transferable and must be presented in their original condition.

1.2 The management reserves the absolute right to refuse entry or eject any individual from the premises without prior notice or explanation, at its sole discretion.

1.3 Ticket holders agree to submit to security searches upon entry to the venue. Refusal to comply will result in denied entry without refund.

2. Prohibited Items

The following items are strictly prohibited from being brought into the venue:

- Alcoholic beverages
- Glass bottles or containers
- Illegal substances
- Weapons of any description
- Fireworks or pyrotechnic devices including flares
- Laser pointers
- Professional camera equipment
- Large bags or backpacks exceeding 30cm x 20cm
- Poles, sticks, or any potential improvised weapons
- Dangerous or offensive banners
- Animals (except registered assistance dogs)
- Sound-generating devices (such as air horns)
- Drones or remote-controlled devices
- Personal cooking equipment
- Helmets or face-covering accessories that impede identification

3. Behavioural Expectations

3.1 Spectators must:

- Conduct themselves in a manner that does not cause nuisance or distress to other attendees
- Follow all instructions from venue staff, security personnel, and stewards
- Remain seated in their allocated seat unless otherwise permitted
- Refrain from discriminatory language, gestures, or behaviour

3.2 The venue operates a zero-tolerance policy towards:

- Racist, sexist, homophobic, or discriminatory conduct
- Verbal or physical abuse
- Attempting to enter restricted areas
- Antisocial behaviour

4. Safety and Security

4.1 In the event of an emergency, spectators must:

- Remain calm
- Follow instructions from venue staff
- Use designated emergency exits
- Assist those who may require help

4.2 The management reserves the right to:

- Implement additional security measures
- Modify entry conditions without prior notice
- Cancel or postpone the event for safety reasons
- Conduct video surveillance throughout the venue

5. Ticket Conditions

5.1 Tickets are sold subject to the following conditions:

- No refunds will be issued except as required by law or in accordance with the Terms and Conditions of Sale
- Tickets cannot be resold without prior written permission
- Duplicated or forged tickets will be rendered invalid

6. Liability Limitation

6.1 The venue management accepts no responsibility for:

- Personal injury
- Loss or damage to personal property
- Indirect or consequential losses

7. Data Protection

7.1 By entering the venue, spectators consent to:

- Being recorded on CCTV

- Potential use of images for promotional purposes
- Processing of personal data in accordance with current data protection legislation

8. Final Provisions

8.1 These terms and conditions are subject to the laws of the Island of Guernsey

8.2 Entry to the venue constitutes full acceptance of these terms and conditions.
